- The identity of any groups or organisations who will be consulted before a decision is made and the way in which consultation will be undertaken
- The way in which anyone can make representations about any matter requiring a decision
- A list of the reports which will be considered before a decision is made

- On page 4 you will find a list of members of the Cabinet showing the Portfolios for which Cabinet Members are responsible. The Council's senior officers are also shown. Representations on any decision can be made to the named contact officer at any time before the date of the decision.
